The Shipper shall be entitled to change the Consignee at any time before delivery of the goods provided he gives the Carrier reasonable notice in writing.

Delivery will be made to the Consignee or his authorised agent on production of reasonable proof of identity (and, in the case of an agent, reasonable proof of authority) without production of this waybill. Except as otherwise provided below, the contract of carriage contained in or evidenced by this waybill and any non-contractual obligation arising out of or in connection with it shall be subject to English law and any dispute arising out of or in connection with it shall be referred to the exclusive jurisdiction of the High Court of Justice in London. For carriage to or from the USA, except as otherwise provided below, the contract of carriage contained in or evidenced by this waybill shall be subject to US law and any dispute arising out of or in connection with it shall be subject to the exclusive jurisdiction of the United States District Court of the Southern District of New York. In any event, for any claim by the Carrier arising out of or in connection with the contract of carriage contained in or evidenced by this Waybill, the Carrier may at its sole option commence proceedings in the courts of the country of the Load Place / Place of Receipt, Port of Exit / Port of Loading, Port of Entry / Port of Discharge, Delivery Place, or the courts of any place where the Merchant (or any Merchant, if more than one is liable under the contract of carriage contained in or evidence by this Bill of Lading) is incorporated or has a place of business.
